## **Chapman and Cutler LLP Recognized for Corporate Equality by the Human Rights Campaign**

CHICAGO (November 21, 2014) – For the sixth year in a row, Chapman and Cutler received a 100% score on the Human Rights Campaign’s (HRC) Corporate Equality Index (CEI), earning the firm a place among the HRC’s Best Places to Work.

This year’s list of organizations with 100% scores includes 366 major U.S. businesses, 89 of which are Am Law 200 law firms. The 2015 CEI rated a total of 149 law firms in the report, which evaluates LGBT-related policies and practices including non-discrimination workplace protections, domestic partner benefits, transgender-inclusive health care benefits, competency programs, and public engagement with the LGBT community. In all categories, Chapman and Cutler received the highest rating possible.

“At Chapman, workplace equality is a core value we live by, both in and out of the office,” notes Tim Mohan, the firm’s Chief Executive Partner. “Our dedication to diversity and inclusion enhances our ability to serve our clients and provides a strong platform for growth and advancement among the attorneys and support professionals within our firm.”

Daley and Equality Illinois gave Chapman and Cutler a special commendation for providing insurance benefits for domestic partners and encouraging broader participation in civic and pro bono activities.

Chapman attorneys participate in programs with Lambda Legal, a national organization for lesbian, gay, bisexual, and transgender people. Additionally, Chapman’s internal LGBT Affinity Group monitors policies and helps implement the firm’s Diversity Action Plan, which has been expanded to include a supplier diversity program.
