Chapman Recognized by the Human Rights Campaign Foundation for LGBTQ Equality

Chapman and Cutler LLP was named one of the Best Places to Work for LGBTQ Equality, receiving a 100% score on the annual Corporate Equality Index.

CHICAGO, November 9, 2017 — For the ninth year in a row, Chapman and Cutler LLP received a perfect, 100% score on the 2018 Corporate Equality Index (CEI) administered by the Human Rights Campaign Foundation (HRCF), earning the firm a place among the Best Places to Work for LGBTQ Equality.

Chapman is among 609 major US businesses, including 127 AmLaw 200 law firms, recognized with top marks this year. The 2018 CEI rated a total of 160 law firms in the report, which evaluates LGBTQ-related policies and practices including non-discrimination workplace protections, domestic partner benefits, transgender-inclusive health care benefits, training programs, and public engagement with and commitment to the LGBTQ community. In all categories, Chapman received the highest rating possible.

“It’s no surprise that many top-scoring businesses are also top-performing businesses,” said HRCF President Chad Griffin. “They know that creating inclusive workplaces and communities where their employees can thrive is an investment in their own competitive edge.”
